Attic, Cathedral & Flat Roof Insulation	Minimum Insulation at time of Post Audit	Maximum Rebate ¹
Attic Insulation: Less than or equal to R-12 at time of Pre-Audit	R-50	\$1,500
Attic Insulation: R-13 to R-25 at time of Pre-Audit	R-50	\$1,200

² If insulating basement and crawl space walls, maximum amount is capped at \$1,500 for both. Semi-detached and row homes receive prorated benefits.

³ Foundation header can be a basement header, a crawl space header, or a combination of these two. Wall + Header = 1 measure.

Exterior Wall ³ : R-7.5 to R-12 added between Pre/Post Audit	\$1,200
Exterior Wall ³ : Greater than R-12 to R-20 added between Pre/Post Audit	\$2,100
Exterior Wall ³ : Greater than R-20 added between Pre/Post Audit	\$3,600
Exposed Floor4: R-20 or Greater added between Pre/Post Audit (minimum of 120 sqft or 11 square meters)	\$300

Achieve Base Target on the Renovation Upgrade Report	\$120
Achieve 10%+ above the Base Target on the Renovation Upgrade Report	\$180

Windows, Doors & Skylight	Rebate Amount
Each window, door or skylight replaced with an ENERGY STAR certified model ⁵	\$50 per rough opening

SMinimum of 3 windows, or 1 door or 1 sliding door or 1 skylight replaced with ENERGY STAR certified models required to count as (1) measure. ENERGY STAR stickers must be present on each window/door at time of final audit.

EXAMPLES OF REBATE COMBINATION OPTIONS

- A Cold Climate Heat Pump + Attic Insulation = up to \$3,500 rebate (with a 4 Ton unit) *
- B Attic Insulation + Basement Wall / Header Insulation = up to \$3,300 *
- C Attic Insulation + Basement Wall / Header Insulation + Air Sealing = up to \$3,480 *

*Audit reimbursement of \$600 would be in addition to the amounts listed above
